In this context, you are being informed that as per the decision taken by this Ministry, Scholarship amount to eligible Minority Students under PMS and MCM based Scholarship Schemes will be transferred directly into beneficiaries bank account from 2014-15 in Direct Benefit Transfer (DBT) mode through the portal of Public Financial Management System, in the Department of Expenditure, Ministry of Finance.

2. One of the essential processes for effecting DBT is the verification of the applicants bank accounts while scrutiny through online Scholarship Management System. Hence the Head of the institutions must make sure that the Applicant Name and Name of payee mentioned in the online application form as same. Secondly, the Aadhaar Number entered in the online application form should be correct and seeded with applicants Bank account Number.

3. It is requested that necessary directions may be issued to your subordinate institutions / schools, etc. in this regard, so that the Scholarship amount could be transfer to selected beneficiaries without any transaction delay.
