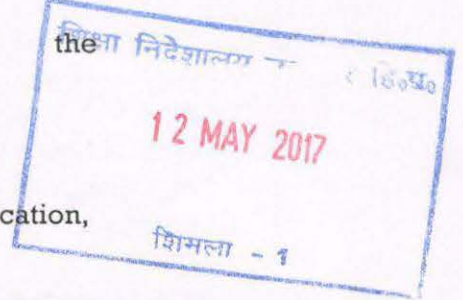

Item 5. Preparation of calendar for the capacity building of District Resource Group of SLDP for the year 2017-18

All the concerned Dy. Directors and DPOs (SSA/RMSA) should depute 5-10 DRG members (from amongst school heads who have already worked as facilitators) from each district and TTIs SSA and RMSA both for the zone level SLDP workshops as proposed above. All the DRG members will be provided hard and soft copies of the material during the workshop. Boarding / lodging arrangements for all participants / RPs to be made by the zone level DPO. DRG members and TTIs shall claim their TA / DA from their respective DIETs. RPs / facilitators will be paid honorarium at the zone level by the concerned DPOs. For Kinnaur and L&S districts, 10 days SLDP will be organized separately as discussed with NUEPA in the month of June / July, 17.

Item 6. Preparation of calendar for 10 days capacity building of school heads under SLDP for the year 2017-18

It was decided that first phase of 10 days capacity building programme for school heads under SLDP (except L&S and Kinnaur districts) for the year 2017-18 along with follow-up will be undertaken at the district level on following dates as decided in the workshop:-

Districts	10 days	First follow up	Second follow up	Third follow up
All districts except L&S and Kinnaur	12-21 st June, 2017	26-27 th September, 2017	6-7 th November, 2017	19-20 th February, 2018

The dates for the second phase of the capacity building programme of school heads under SLDP for the year 2017-18 along with follow-up will be decided by the districts where the target group for elementary and secondary school heads would be more than 60. The calendar for (first phase, second phase and follow-up reviews) must reach this office by 30th May, 2017 positively.

Item 7. Preparation of calendar for the follow-up reviews under SLDP

Districts will prepare the calendar of follow-up reviews for those school heads who have already undergone 10 days capacity building programme under SLDP in previous years. This

exercise should be carried out in a phased manner till every school head completes 10+2+2+2 cycle. The calendar must reach this office by 30th May, 17 positively.
