

I wish to invite your kind attention to the National Conference of Chief Secretaries and Planning Secretaries of the States/UTs held on 27th July, 2016 at New Delhi, which was attended by me. Different presentations were made in the Conference by the participants. Some very important suggestions emerged during the deliberations.

The Chief Secretary, Maharashtra suggested that there is a need to study the reasons for the repeated visits of the public to the Govt. offices. The obvious reason to this is the cumbersome procedures which need to be simplified.

I would request you to kindly study the existing system of the day to day working and suggest measures for simplification of procedures, so that visits of general public to the government offices is reduced.
