HIMACHAL GAURAV PURSKAR-Instuctions thereof:

Himachal Gaurav Purskar was started in the 1992. Persons of either 'sex' in all walks of life are eligible for Himachal Gaurav Purskar. The Members of Armed Forces, Police Forces and the recognized Fire Services etc. are eligible for the purskar provided the life saving act/ gallant work is performed by them otherwise than in the course of their duty. The award can also be conferred posthumously. The Person,/ Group of persons, who is to be decorated with the Himachal Gaurav Purskar should either be Himachali or the commendable job should have been done in/ for Himachal Pradesh.

(I) <u>Life Saving Act</u>: The persons, who save the life of persons by endangering their own life and showing exemplary courage to save the life of a person are eligible for consideration of Himachal Gaurav Purskar as under:

- i) For conspicuous courage in saving life under circumstances of very great danger to the life of the rescuer.
- ii) For courage and promptitude in saving life under circumstances of great danger to the life of the rescuer.
- iii) For courage and promptitude in saving life under circumstances of grave bodily injury to the rescuer/gallantry

(II)Art and others: The persons who have done commendable job in following fields are also eligible for consideration of Himachal Gaurav Purskar:-

Arts, Social Work, Public Affairs, Science & Engineering, Trade & Industry, Medicine, Literature & Education, Civil Services, Others (fields not covered above and may include propagation of Himachal Culture. Protection of Human Rights, Wild Life Protection/ conservation etc.)

(III)Sports:_Outstanding sports persons of the State who have won medals in various recognized National/ International level Championships are also considered for Himachal Gaurav Purskar.

Though the awards for the persons doing commendable job in the fields stated above are considered by the concerned departments, nevertheless the State Government can consider the name for Himachal Gaurav Purskar on the merit of the case.

Presentation: There will be maximum four awards in a year, Three for individuals and one for a group. The award will be presented by Hon'ble Chief Minister in State Level Function of Himachal Day i.e. 15th of April every year. The composition of the Award will be as under:

For Individual:

i) Cash Award- Rs. 21000/-

ii) Himachali Shawl & Cap.

iii) Citation

For Group

i) Cash Award-Rs. 1,00,000/- (not exceeding 20,000/- per head)

ii) Himachali Shawl & Cap (for each member)

iii)Citation (for each member)

(All the awardees will be treated as State Guests for participating in the Award Ceremony.)

<u>Procedure for Selection</u>: All the recommendations received from the respective HODs/ DCs will be scrutinized by the Screening/ recommending Committee constituted for the purpose The Committee shall consist following members:-

Recommendations: All the quarters concerned in the Himachal Pradesh are requested to send the recommendations of those persons/ Group of persons whose cases are not covered under the instructions of awards instituted by the Government of India like Padma Awards, Jeevan Raksha Padak series of awards and Ashok Chakra series of awards on the prescribed proforma endorsed with the letter with in very two calendar years from the date of incident / performance of act. It may also be ensured that cases not covered under the instructions of Himachal Gaurav Purskar will be disposed of by the concerned Deputy Commissioner / Department at their own level by giving them appreciation letter / appropriate cash award. Last date for receiving nominations/recommendations in GAD is 31st of December.

CIVIL SERVICE Award under Scheme of incentives for deserving Government employees :-

Scheme Circulated by Department of Personnel to all Administrative Secretaries / HODs/ DCs vide letter No.: Per (AP-B)B(11)-2/2003 Dated: 28th July 2008., is administered through GAD.

Under this Scheme Govt. employee / group of employees will be rewarded with **Civil Service Award** for exceptional performance/ setting high standards of service. A unit or a group of employees will be given preference over an individual if that exceptional work has been achieved by the joint efforts of a group of officials.

Presentation: This award will be presented by the Hon'ble Chief Minister in State Level Function of Himachal Day, 15th of April, every year. Under this Scheme there will be maximum of 4 awards in a year. The composition of the Award will be as under:

(i)Himachali Shawl & Cap.

(ii)Cash Prize of Rs 51000/- in case of individual and Rs. 2,50,000/- to a group/ organization but not exceeding Rs. 50,000/- per individual.

(iii) Citation

(The Awardees will be treated as State Guests when invited for receiving the Awards.)

Nominations for the said award will be decided by the State Level Committee constituted under the Chairpersonship of Chief Secretary to the Govt. of H.P., who will scuitinize the nominations so received. The composition of the Committee will be as under:

1. Chief Secretary	Chairperson
2. Pr. Secretary to Chief Minister	Member
3. Pr. Secretary Finance	Member
4. Concerned Administrative Secretary	Special Invitee
5.One non-Official Member, who is eminent Citizen or retired Civil Servant.	Member
6. Secretary (GAD)	Member Secretary.

PADMA AWARDS

- Padma Awards were instituted in the year 1954. Except for brief interruption(s) during the years 1978 and 1979 and 1993 to 1997, these awards have been announced every year on Republic Day.
- The award is given in three categories, namely, Padma Vibhushan, Padma Bhushan and Padma Shri.
- Padma Shri is awarded for 'distinguished service';
 Padma Bhushan for 'distinguished service of a high order'; and
 Padma Vibhushan for 'exceptional and distinguished service.

No.

- The award seeks to recognize work of any distinction and is given for distinguished and exceptional achievements/service in all fields of activities/disciplines, such as Art, Literature and Education, Sports, Medicine, Social Work, Science and Engineering, Public Affairs, Civil Service, Trade and Industry etc.
- All persons without distinction of race, occupation, position or sex are eligible for these awards.
- The award is normally not conferred posthumously. However, in highly deserving cases, the Government could consider giving an award posthumously if the demise of the person proposed to be honoured has been recent, say within a period of one year preceding the Republic Day on which it is proposed to announce the award.
- A higher category of Padma award can be conferred on a person only where a period of atleast five years has elapsed since conferment of the earlier Padma award. However, in highly deserving cases, a relaxation can be made by the Awards Committee.
- It is the usual practice is to invite recommendations every year from all State/UT Governments, Ministries/Departments of the Government of India, Bharat Ratna and Padma Vibhushan awardees and Institutes of Excellence by 1st October. Recommendations received from them and also from other sources like Ministers, Chief Ministers/Governors of State, Members of Parliament, as also private individuals, bodies etc., are placed before the Padma Awards Committee. The Awards Committee is constituted by the Prime Minister every year.
- The recommendations made by the Awards Committee are submitted to the Prime Minister and the President for their approval. No award is conferred except on the recommendation of the Awards Committee.
- The total number of awards to be given in a year (excluding posthumous awards and to foreigners) should not be more than 120.

• The names of the award winners are published in the Gazette of India. The President may cancel and annul the award of the decoration to any person.

- The Awards are announced on 26th January every year and are presented by the President of India in an Awards presentation Ceremony held at Rashtrapati Bhavan. The ceremony is generally held in the month of March/April.
- The decoration comprises a Sanad (Certificate) issued under the hand and seal of the President and a Medallion. A commemorative brochure giving out brief details in respect of each award winner is also released on the day of the investiture ceremony.
- The recipients are also given a replica of the medallion, which they can wear during any ceremonial/State functions etc., if they so desire.
- The award does not amount to a title and cannot be used as a suffix or prefix to the award winner's name on letterheads, invitation cards, posters, books etc. In the case of any misuse, the defaulter will forfeit the award.
- No cash allowance or any facility/benefit in terms of concession etc. in rail/air travel is attached to these awards.
