The Department of information Technology, HP has listed below few points for reference on the

subject:

- "Not Active Records" means the records which does not require any further processing and are in their final stage of outcome. Example of such records may be signed agreements.signed copies of SLAs, transaction records,etc.which are non-changeable in nature. These documents may be archived(preserbed) now for reference at a later point of time.
- The government departments will identify the records for archival.
- The archival of the of the records would then be done by following the standard for Preservation information Documentation of Electronic Records.
- The eRecord Manageme System is being development by C-DAC

You are, therefore, requested to take necessary action in identifying the records for archival with intimation to this department. The eRecords Management System may further be discussed with C-DAC for implementation in specific user scenarios. The implementation of these standards is important from the view point to promote the usage of Open Standards to avoid any technology lock-ins.
