Memo;

This is reference to the Sanction Order amounting to Rs. 7,00,000/-(Rupees Seven Lacs only) for construction of Lab/workshop for 100 Government Senior Schools under NVEQF in Himachal Pradesh received from Ministry of Human Resource and Development, New Delhi. Following instructions should be strictly adhered to before proceeding with the construction activities.

- The construction shall be carried out as per architectural drawings and structural designs of school workshop/Laboratory got prepared through (NIT), Hamirpur/HPPWD/HIMUDA/BSNL(copy enclosed). No change in Structural Designs be made if it is to be framed structure. If changes are needed to be made, it is suggested that preference should be given to load bearing structure.
- 2. The workshop/laboratory to be constructed should be of 10 X 10 Sq. metre.
- 3. The construction work should be completed in the said amount and no additional funds shall be provided for the work.
- 4. The construction work should be carried out through the registered Contractors.
- 5. Practice should be followed to procure the construction material such as cement, CGI Sheets, Steel, etc from the outlet of H.P. State Civil Supplies Corporation. If the same is not available at State Civil Supplies Corporation, then before procuring the construction material from the open market, NOC from State Civil Supplies Corporation should be obtained.

To

- 6. If the land where construction is to be carried out happens to be a forest land then the same should be transferred in the name of Education Department after completing all the codal formalities in the first instance.
- 7. Time period for the completion of the work should be eight months after assigning the work.
- 8. Work should be carried out under the supervision of the Principal/SMC/SMDC/Junior Engineer SSA and RMSA. The Principal should be fully responsible to carry out the work and to provide the utilization certificate of the said amount to this office.
- 9. Initially Rs. 3 Lacs are being allocated for construction of Lab/workshop. Rest of the amount shall be sanctioned as per requirement.
- 10. Funds already provided to schools where land is not available or the said construction has been taken up by any other agency should be returned forthwith with detailed reasons without any delay so that the same are provided to the schools where infrastructure is required.
- 11. The second lab/workshop for another vocational subject will also be constructed as and when the amount will be received from Government of India.
