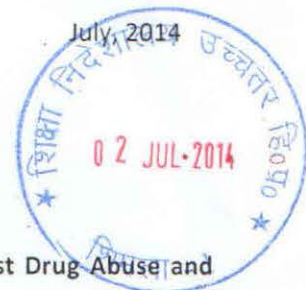

- Seminars on drug abuse in training institutions/voluntary organizations
- Workshops to evolve new coordinated strategies for supply reduction and demand reduction by various enforcement agencies/NGOs
- Exhibition on drug abuse in different cities and towns
- Flashing of SMS through various service providers
- Regional languages programmes to be telecast broadcast by Doordarshan All India Radio and other electronics channels
- Wide publicity by way of displaying and distribution of banners, posters, pamphlets, slide show in cinemas etc.

In this connection, you are directed to give necessary direction to the Principals/Headmasters under your jurisdiction to celebrate International day against Drug Abuse and Illicit trafficking continuously for a fortnight to create awareness among students & public against the menance of drugs.

Further all the Principals of Govt. Colleges/Govt. Aided colleges are also directed to organize similar programme in their respective colleges.
