This is with the reference to the Principal Secretary (Education) to the Govt. of Himachal Pradesh, Shimla-02 vide his letter No. EDN-A Kha (1)-2/2013 Dt.26th June, 2013 regarding rationalization of posts of Assistant/ Associate Professors in Skt. colleges under CBCS/ Semester System.

In this connection, the undersigned has decided to constitute the following committee to propose the norms of rationalization under the chairmanship of Dr. Amar Dev Jt. Director of Hr. Edu, as the existing norms of rationalization are not feasible under the CBCS/ Semester System, which has recently been started in phased manner in the Skt. colleges by the Govt. Therefore, keeping in view the newly adopted system of quality education the norms of rationalization are required to be revised by constituting a committee of expert educationists under the consultation with the HP University where choice based credit system has been formulated. Therefore, all members are requested to attend the workshop fixed on 1st August 2013 at 11.15 AM in the chamber of Joint Director (Colleges), so that norms for the same could be proposed for further approval of the Govt.
