
Office Order

In continuation to this Directorate Office order No. EDN-H(19)B(1)08-contract Lecturer 2008, dated: 31.12.2008, 12.1.2009, 17.1.2009, 19.01.2009, 23.1.2009, 31.01.2009, 06.02.2009, 25.02.2009, 02.03.2009, 10.03.2009 and 10.06.2009, office order No. EDN-H(19)B(1)-1 2009-Contract, dated: 20.01.2010, EDN-H(19)B(1)1 2009-Spl.contract, dated: 25.11.2009, EDN-H(19)B(1)-2 2009-contract, dated: 01.12.2009, EDN-H(19)B(1)-25/2010-Reg.contract, dated: 27.07.2010 and EDN-H(19)B(1)6/2010-CWP(T)3/2010, dated: 27.12.2010, whereby a specific condition 2(e) has been mentioned therein which read as under:-

"The services of such school lecturers who have completed eight years of continuous service as on (date) do not possess the B.Ed. degree will only be awarded annual increment and promotion after they acquire B.Ed. degree."

Now, vide letter No. Shiksha-II-Kha(12)-2'99-Loose, dated: 12.09.2012 this has been conveyed by the Govt. that in respect of those incumbents who have been appointed as lecturer (School Cadre) on contract basis prior to 04.08.2005 (the date from which the condition of B.Ed. qualification have been incorporated/ prescribed in the R & P Rules), this condition No. 2(e) will not be applicable on their regularisation. Therefore as per this relaxation conveyed by the Govt. all those incumbents who were regularised vide above mentioned orders would be entitled for annual increment after a qualifying service of twelve months which is to be reckoned from the date of regularisation.
