TERMS & CONDITIONS

- 1. The Contractual appointee will be paid fixed contractual amount @ Rs.7810/- p.m. (which shall be equal to minimum of the pay band + grade pay). The contract appointee will be entitled for increase in contractual amount @ Rs. 234/-(3% of minimum of the pay band + grade pay of the post) for further extended years and no other allied benefits such as Senior/Selection scales etc. will be given.
- The service of the contract appointee will be purely on temporarily basis. The appointment is liable
 to be terminated in case the performance/conduct of the contract appointee is not found
 Satisfactory.
- 3. Contract Appointee will be entitled for one day casual leave after putting one month service. However, the contract employee will also be entitled for 135 days Maternity Leave and 10 day's Medical Leave and 05 days special leave.
