Sir/Madam,

I am directed to refer to the subject cited above and to say that the Division Bench of Hon'ble High Court of Himachal Pradesh, while disposing of CWP No. 3310 of 2011-D titled as Leela Devi Vrs. State of Himachal Pradesh & others, and other connected matters on 12.12.2011, has directed the State Government that the cases of all those Part Time Water Carriers, who have completed 10 years of service as such, shall be converted to the status of Whole Time Contingent Employees on daily waged basis (No retrospective effect).

- 2. The Government, after due consideration and in compliance to the judgment dated: 12.12.2011 of Hon'ble High Court and subsequent judgments of the Hon'ble High Court in this regard, has decided that all the Part Time Water Carriers, on conversion as Whole Time Contingent Workers, will be allowed daily wages, as fixed by the Government from time to time.
- 3. These instructions shall supersede all the previous instructions issued by the Government containing norms for fixation of emoluments of whole time contingent paid employees.
