Subject:- PAYMENT OF TA/DA TO THE OFFICIALS APPOINTED ON ELECTION DUTY FOR THE CONDUCT OF GENERAL ELECTIONS TO PANCHAYATI RAJ INSTITUTION AND URBAN LOCAL BODIES

Sir/Madam,

The General Election to the Panchayati Raj Institution and Urban Local Bodies in the state are due this year end. Article 243-K(3) of the constitution of India read with Section 160(3) of the H.P. Panchayati Raj Act 1994 provides that the Governor shall, when so requested by the State Election Commission make available to him such staff as may be necessary for the discharge of the functions conferred on the State Election Commission.

In pursuance to the said provision the staff from the all the Departments, Boards, Corporations and Government undertaking is being deputed to conduct the elections. The Commission pay the TA/DA to the officials deputed on election duty. Presently the expenditure on account of TA/DA is born by the Commission and T.A claims of the such officials are forwarded to the District Election Officers by the respective head of departments/offices. Thereafter these bills are processed by the District Election Officers(Panchayat) and the payment is sent to the respective offices for the onward payment to the officials.

Since the Commission do not have adequate staff at district level which causes delay in the payment of TA/DA to the said officials engaged in the election duty besides a lot of time energy and postage is also wasted in processing and payment of the TA Claims.

The matter was under consideration of the Commission and now I am directed to convey that the Commission has decided that as per practice prevalent in the Vidhan Sabha and Lok Sabha Election the TA/DA on account of election duty will be paid by the respective Departments/Organizations
