In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor, Himachal Pradesh, in consultation with Himachal Pradesh Public Service Commission, is pleased to make the following Rules further to amend the "Himachal Pradesh, Higher Education Department, Post Graduate Teacher, Class-III(Non-Gazetted) Recruitment and Promotion Rules, 2010 notified vide this Department notification of even number dated 20th Sept.2010; namely:-

(1) These rules may be called the Himachal Pradesh Higher Education Department, Post Graduate Teacher, Class-III (Non-Gazetted); Recruitment and Promotion, (1st Amendment) Rules, 2011. | Amendment of Annexure-A | 2. In Annexure-A to the Himachal Pradesh, Higher Education Department, Post Graduate Teacher, Class-III (Non-Gazetted) Recruitment and Promotion Rules, 2010,- a) For the existing provisions against Col. No.7 the following shall be substituted, namely:- <u>Essential Qualification(s):</u> <u>Academic Qualification:</u> 1. Master's Degree in the subject concerned from a recognized University (with minimum of 50% marks in aggregate) or its equivalent in the following subjects:- a) Post Graduate Teacher(English): English b) Post Graduate Teacher(Hindi):- Hindi c) Post Graduate Teacher (Sanskrit):- Sanskrit. d) Post Graduate Teacher (Mathematics): Mathematics/Applied Mathematics. e) Post Graduate Teacher (Physics):- Physics/Electronics/Nuclear Physics. f) Post Graduate Teacher (Chemistry):- Chemistry/Bio-Chemistry. g) Post Graduate Teacher(Biology):- Biology/Zoology, Life Microbiology/ Bio- |

Technology/Molecular Biology/Plant Physiology provided they have studied Botany and Zoology at Graduation level.

- h) Post Graduate Teacher(Home Science):- Home Science
- i) Post Graduate Teacher(Sociology):- Sociology.
- j) Post Graduate Teacher(Music):- Music (Instrumental/Vocal)
- k) Post Graduate Teacher(History):- History
- l) Post Graduate Teacher(Geography):- Geography
- m) Post Graduate Teacher(Commerce):- Commerce with Accountancy/ Financial Accountancy and Income Tax as major subjects of study. Holder of Degree of MFC(Master of Finance Control) is also eligible for the post of Post Graduate Teacher in Commerce subject from a recognized University.
- n) Post Graduate Teacher(Economics):- Economics/Applied Economics/ Business Economics.
- o) Post Graduate Teacher(Political Science):- Political Science
- p) Post Graduate Teacher(Informatics Practices):- Informatics Practices- B.E. or B.Tech. in Computer Science/ Information Technology or equivalent degree from a recognised University/ Institute

OR

B.E. or B.Tech(any stream) from a recognised University/Institute and Post Graduate Diploma in Computer Sciences/Technology/Applications or equivalent from a recognised University/Institute.

OR

M.Sc.(Computer Science)/MCA or equivalent from a recognised University/Institute.

OR

Post Graduate Degree in Mathematics/Physics from a recognised University with Post Graduate Diploma in Computer Sciences/Applications from a recognized University/Institute.

OR

"B" or "C" level course from DOEACC Society-

Ministry of Information and Communication Technology.

i) Post Graduate Teacher (Public Administration):- Public Administration

ii) Post Graduate Teacher (Psychology):- Psychology.

ii) Proficiency In teaching Hindi and English.

2. **Professional Qualification:**

i) Bachelor Education (B.Ed.) as professional qualification from recognized University/Institutions with minimum 50 % marks.

OR

Two years integrated M.Sc. Ed Course or an equivalent course from a recognized University.

ii) Post Graduate Teachers (Informatics Practices) are exempted from B.Ed.

Provided that for M.Com. Candidates, B.Ed. qualification will not be essential till the expiry of period of three years from the date H.P. University allows B.Com./M.Com. Candidates to undertake B.Ed. Degree/Course.

NOTE:-

(i) In case of Post Graduate Teacher in Biology subject the candidate must have qualified Post Graduate Degree of M.Sc. in Botany/Zoology/Life Sciences/Micro Biology/Bio-Technology/Molecular Bio Plant Physiology provided they have studied Botany and Zoology at graduation level.

ii) In case of Post Graduate Teacher in Commerce, the candidate must have passed M.Com. from a recognized University

iii) The candidates having Master Degree in Public Administration are eligible for the post of Post Graduate Teacher in Political Science subject.

iv) In case of Science subjects i.e. Physics, Chemistry and Biology; candidates must have obtained the degree of M.Sc. as regular candidates. However, the candidates who have obtained the degree of M.Sc. or admitted in M.Sc. through distance education Mode prior to 06-04-2010 for the subjects are eligible.

(b) **Desirable Qualification(s):-**

Knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.

- i) 50% by promotion.
Provided that in case of promotion of PGT(Informatics Practices), if suitable candidates(s) are not available, then the said posts shall be filled up 100% by direct recruitment on a regular basis or by recruitment on contract basis, as the case may be. The contract employees will get emoluments as given in Column 15-A and will be governed by service conditions as specified in the said column.
