Sir/Madam,

I am directed to forward herewith a copy of letter no. 2-5/2008-PP dated 17<sup>th</sup> April, 2016 received from National Disaster Management Authority (NDMA), New Delhi on the above mentioned subject, enclosing therewith an indicative list of States/UTs prone to flood and cyclones.

1. NDMA has informed that due to Southwest (SW) monsoon from June to September, cyclones may occur in the months of May-June and October-December, with their primary peak in November and secondary peak in May. Around 70-90 percent of the annual total rainfall over different parts of India occurs in the SW monsoon season.

2. In view of impending monsoon season, pre-monsoon preparedness for mitigation measures and efficient response would result in saving precious lives and minimizing damage to property and infrastructure. You are therefore, requested to advise the concerned authorities to take necessary preventive measures, especially for the safety of Staff and Children in Schools.

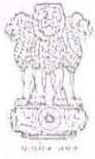

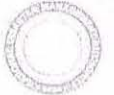
