Principles for promotion to selection posts-Clarification thereof.


Sir/Madam,

I am directed to invite your attention to this Department letter No. Per(AP-B)B(19)25/2007-Loose dated 05-01-2013 on the subject cited above vide which clarificatory instructions have been issued relating to two instructions dated 3/4 November, 1981 and 27<sup>th</sup> May, 1996. Later on, the instructions dated 05-01-2013 have been decided to hold in abeyance by the State Government vide letter No. Per(AP-B)B(19)-25/2007-loose dated 3<sup>rd</sup> May, 2013.

The instructions dated 3/4-11-1981 have been reviewed and new procedure to be observed by DPCs to consider promotion to the selection posts has been laid down vide O.M. No. Per (AP-B)B(3)-1/94 dated 27<sup>th</sup> February, 2016 in supersession of instructions referred to above. By devising/prescribing new procedure vide O.M dated 27<sup>th</sup> February, 2016, the instruction issued on 05-01-2013 has automatically stand repealed and ought to be considered that the same have never been issued.


