The Governor, Himachal Pradesh is pleased to order to amend the Clause 08 of the 'Grant-in-Aid to Parents Teachers Associations Rules, 2006' notified by this Department vide No. EDN-A (Kha) 07-3/2006 dated 29-06-2006 and as amended from time to time as under:-

"8. Quantum of Grant-in-Aid:- The amount of grant to a PTA (GIA) provided teacher engaged on or before 02.01.2008 against the following vacant posts by the PTAs shall be as under with effect from 01st June, 2017:-

1.	Assistant Professor (College Cadre)	Rs. 26,100/-
2.	PGT (School Cadre)	Rs. 17,650/-
3.	DPEs, TGTs	Rs. 16,600/-
4.	C & Vs Teachers	Rs. 15,900/-

In case the teacher is made available or works for a period less than one month, the grant shall be reduced prorata."


