Kindly refer to your office letter No. EDN-H(21)F(2)37/2012-SGAI dated 08.05.2015 on the subject cited above.

In compliance of the decision taken in the 102nd Board meeting dated 28/01/2014, the Student Career Aptitude Test for the 10th class students of the State is to be conducted by the board on the lines of CBSE in near future. Before taking any action in this regard it is requested that this test may kindly be made mandatory for every student so that maximum number of candidates can participate in this test. This test will be conducted both for Co. i.e. Private schools affiliated to 11PEOSE. In 2013 this test was optional and only 19397 candidates out of 1.50 lakks students appeared in this test. If this test remains optional then less students may apply for the same, thereby making the test un-economic and non-feasible for the board.

You are therefore requested to kindly issue necessary directions to the field functionaries in this regard. The test will be conducted on the same pattern as conducted by CBSE in 2013.
