PROPOSAL FOR CHANGE OF VACATION, ADMISSION AND EXAMINATION SCHEDULE IN RESPECT OF COLLEGES IN THE STATE for 2016-17

For Semester System (1st year Class)in phased manner....

The Semester System has been introduced in the Colleges of Himachal Pradesh from the 1st year of degree courses from the session 2013-14. In view of this, the proposed admission/vacation/examination schedule for the academic session 2016-17 is as under: -

Note:- It will be mandatory for every college to display time table giving all the details about Major/Minor/Elective subjects etc. in the Ist week itself after the closure of all admissions i.e. Ist July itself, so that the students can choose their minor/elective/Gl&H subjects as per the time table and this week will be called as Zero Week.

- The regular teaching to classes of 1/III and V Semester will commence from 1st July, 2016 to 14th October, 2016 i.e. 15 weeks.
- End Semester Examination (Practical/ Theory) of 1/III and V Semester will commence from 15th October, 2016 to 14th November, 2016 = 30 Days.
- Evaluation of 1/III and V Semester examination 15th November, 2016 to 23rd November, 2016 = 9 Days.
- 11/1V and VI Semester regular teaching starts w.e.f.
- 24th November, 2016 to 31st December, 2016 = 38 Days
- 11th February, 2017 to 28th February, 2017 = 18 days
- 1^{st} March, 2017 to 14^{th} April, 2017 = 45 Days
 - Total = 101 Days
- End Semester Examination (Practical/ Theory) of II/ IV and VI Semester 15th April, 2017 to 20th May, 2017 = 36 Days.
- Evaluation of II/ IV and VI Semester examination 21st May, 2017 onwards till 31st May, 2017.

Note: - Admission is open for all students on Roll on Basis, who are otherwise eligible without waiting for the final result. Roll On system means the student who has appeared in the 1st/3rd & 5thSemester will go to the 2nd/4th & 6th Semester as per the schedule without waiting for the result of the 1st/3rd & 5thSemester. However, he/she will have to fulfill all the formalities laid down by the college authorities like filling up of the admission form, if any, and depositing the prescribed fees. This will help to start the regular teaching of 2nd/4th & 6thSemester in time.

Principal may ensure that there is no provision of admission as per university ordinance after 30th June of every year and as per Hon'ble High Court Decision, no admission will be given after the schedule. Principal concerned will be responsible for strict compliance of the admission schedule.
