Subject:- Representation regarding unjust/arbitrary reduction in Pension of Smt. Sarla Mahajan, Asstt. Lib. (Retired) PPO No 11701556/H.P.

Sir,

I have the honour to refer your letter No. EDN-A-Chha(7)-20/98-I-Loose, dated 21.02.2013, on subject cited above.

In this connection, it is submitted that the pay of Smt. Sarla Mahajan, was not rightly fixed. All the Asstt. Librarians were allowed pay scales of as per Hon'ble Administrative Tribunal orders as a measure personal to them

Whereas the actual pay scales of the post were Rs.1200-2100 from 01.01.1986 and Rs. 4020-6200 from 01.01.1996 onwards. She was drawing Basic Pay at the maximum i.e. Rs.1200/- in the pay scale of Rs. 700-1200 as on 31.12.1984. She was allowed annual increment on 01.11.1985 for which she was not entitled as she was to be allowed to draw biennial increment after her drawing pay at the maximum of pay scale, which resulted into over payment to her. Furthermore, the higher pay scale in the hierarchy pay scales on award of ACPs is available to Govt. servants with reference to the actual pay scale of the post, however personal scale has to be protected. As such she was also allowed the Grade Pay and higher pay scale next in the hierarchy of personal pay scale which was irregular. Her pay is re-fixed. Therefore, her pay fixation was rectified vide letter dated 08.04.2011, which is in order.
