REQUISITION ORDER

In exercise of the powers vested in me under Section 160 R P Act, 1951, I, Ajit Kumar Bhardwaj, Returning Officer (SDM), Shimla (U) do hereby requisite the different Govt. / Semi Govt./ Private Complexes to conduct the Vidhan Sabha Election-2017. All the following polling stations locations which are already notified as polling stations by ECI (shown in the enclosed list) are hereby requisitioned w.e.f. 06-11-2017 to 09-11-2017 in respect of 63-Shimla Assembly Constituency. All the Heads/ Incharges of the Departments are hereby directed to provide necessary furniture and fixture to polling parties and to co-operate them for the smooth conduct of Vidhan Sabha Election-2017. Responsible officer/official may be deployed at polling station to extend the co-operation to polling parties w.e.f. 7th to 9th November, 2017. In addition to this, they are further directed that one class-IV employee may be deputed at each polling station for the arrangement of drinking water facility on the day of poll i.e. 9th November, 2017.

Non-compliance of orders will invite stringent punitive action under section 167 of RP Act, 1951.
