The Govt. of Himachal Pradesh has notified/framed policy on Mukhya Mantri Shikshak Yojna for the year 2016 was announced by the Hon'ble Chief Minister while presenting budget estimates for the financial year 2016-17 in Vidhan Sabha for motivating teachers to give good results in subjects like Maths, Science and English etc. Under the scheme one year extension in service will be given to such teachers who have consistently given hundred percent results in Board Examination for a period of five years in respect of such subjects to be notified by the Department of Higher Education (Copy of Scheme enclosed).

NOTIFICATION

The Governor of Himachal Pradesh is pleased to institute a scheme named as "Mukhya Mantri Shikshak Samman Yojna" to motivate all those teachers (TGT/PGT/Headmasters/Principals) of the State who have been consistent in giving 100 percent results in Board examinations for a period of five years in the subjects of Maths, Science and English. Such Teachers will be given extension in service and monetary rewards. The Scheme will be applicable from the Academic year 2016-17. The guidelines for regulation/implementation of the scheme are as under:-

Sr. No	Parameters	Particulars
1.	Objectives	The main objectives of the Scheme is to motivate Teachers (TGT/PGT/Headmasters/Principals) to give good results in subjects <u>Math</u> , <u>Science</u> and <u>English</u> etc. by giving them extension in service and monetary rewards.
2.	Applicable Academic year	The Scheme will be applicable from the Academic year 2016-17. If the result of a Teacher (TGT/PGT/Principals/Headmasters) in the year 2016-17 and for the and for the last four years meets the requirements under the scheme, he/she becomes eligible for one year extension in service when he/she is due for retirement.
3.	Eligibility	(1) (a) A Teacher (TGT/PGT) becomes eligible for benefit under the scheme on the fulfillment of following conditions:- (1807)

		<p>i) He/She should have taught Math, Science or English to 10th class/12th class during the last 5 years.</p> <p>ii) The result in these subjects during the last 5 years should not be less than 90%.</p> <p>iii) Average marks of pass students in the class should not be less than 60%.</p> <p>iv) Minimum number of students in a class shall not be less than 10.</p> <p>(b) If a teacher (TGT/PGT) has served in more than one school during the last 5 years, the results of the school concerned where he/she has put in more than 3 months of service will be considered. Thus for some years, results of two or more schools may have to be considered.</p> <p>(2)(a). In addition, Principals and Headmasters who meet the following criteria will also be eligible to get one year extension.</p> <p>i) Result of the school in 10th/12th class where they are or were Headmaster/Principal during the last 5 years in Board classes is more than 90%.</p> <p>ii) The average marks of the pass students in the class are not less than 60%.</p> <p>iii) There is no subject where the result is less than 75%.</p> <p>iv) Minimum students in the 10th/12th class are not less than 10.</p> <p>(b) If a Headmaster/Principal has served in more than one school during the last 5 years, the</p>

		result of the school concerned where he/she has put in more than 3 months of service will be considered. Thus for some years, results of two or more schools may have to be considered.
4.	Quantum of benefit	<p>(i) A teacher (TGT/PGT)/Headmaster/Principal becomes eligible for one year extension in service on the fulfillment of eligibility conditions mentioned under Sl. No 3 above when he/she is due for retirement.</p> <p>(ii) If a Teacher/Headmaster/Principal becomes eligible for 2nd block of five years, he/she will be eligible for another extension in service of one year.</p> <p>(iii) Maximum extension in service will be restricted to two years.</p> <p>(iv) If a Teacher/Headmaster/Principal becomes eligible for 3rd block of five years, he/she will be awarded a cash prize of Rs. 11000/-.</p> <p>(v) The selected teachers will also be awarded with plaque and shawl/muffler/cap on 15th August/25th January by the concerned Chief Guests at the District level.</p>
5.	Procedure for claiming benefit under the scheme	<p>(i) After the declaration of result, the Teacher/Headmaster/Principal concerned has to apply within one year from the date of declaration of result along with details in the prescribed Performa to the Head of Institution where he/she is presently posted.</p> <p>(ii) The Head of Institution after getting the result verified from the record shall also get the result verified from the other schools where the applicant Teacher/Headmaster/Principal was posted during the last 5 years and submit the proposal through Deputy Director of Elementary/Higher Education to Director of</p>

	<p>Elementary/Higher Education to Director of Elementary/Higher Education.</p> <p>(iii) The Director of Elementary/Higher Education will be competent to pass orders to grant one/two years extension in respect of TGTs/PGTs/Headmasters and entry in his service book will also be made.</p> <p>(iv) The proposals of eligible Principals of Govt. Senior Secondary Schools shall be considered at the Govt. level and granted one/two years extension as the case may be.</p> <p>(v) The pay and pensionary benefits of the Teachers/Headmasters/Principals getting extension in service shall be governed as per instructions issued by the Finance Department vide their letter No. Fin.(C)-A (3)-2/13-1. dated 23.06.2015.</p> <p>(vi) The cases of the Teachers/Headmasters/Principals for award of Rs. 11000/- shall be forwarded by the DEE/DHE to the Govt. and the same shall be given to the awardees on 15th August/25th January as the case may be.</p>
