It is directed to ensure that these institutions are made functional only after completing all codal formalities.
  
- It is also further directed to forward the compliance report of functioning of the upgraded institutions with building status in consolidated manner to this Directorate with in a week positively by mentioning the date of starting of classes in these institutions alongwith following information i.e. (1) Name of Institution and Panchayat (2) Name of Block, Tehsil & constituency (3) Name of DDO, Pin & Treasury Code & complex (4) Name of Co-ordination Cluster (5) Whether institution comes under Sub Cadre area/ Difficult Area/ Tribal area mentioned separately. The constituency-wise list of all GHSSs & GSSSSs running in your District may also be provided to this Directorate immediately, so that Govt. may apprised accordingly.
