## Terms and conditions

The services of these DPEs are taken over as a fresh appointment on regular basis on minimum of pay scale of the post. However, their pay has to be protected as a measure personal to them in terms of policy from the date of granting GIA. The past services will not be counted for any other intent and purpose i.e.

- seniority/pensionery benefits/leave etc. They will be placed at the bottom of seniority of the cadre. The services will be considered against the direct quota.
- It will be the personal responsibility of the Principal to inform this Directorate regarding joining of the concerned DPE.
- That the educational and professional qualifications possessed by the candidate will be the same as prescribed by the Department for the post of DPE. The Head of the school will also ensure that the educational and professional qualification possessed by the candidate is from a recognized University. All necessary verification to this effect is to be made by the Head of the concerned school at the time his joining. Duly attested copies of certificates be kept in the office for future record. In case education/professional or any other certificates of the individual concerned are found fake or from unrecognized university/board services of such individuals in that event will be liable to be terminated.
- The candidate belonging to schedule caste/schedule tribe/OBC classes will furnish the requisite certificates on prescribe proforma duly issued by the competent authority.
- 5. Every employee shall have to serve at least one term in the Tribal/Difficult area subject to adequate number of post(s) available in such area. If posted in non Tribal/Non-Difficult are he shall be posted at any time in Tribal/Difficult area as per need of the Department in relaxation of all terms and conditions.
- 6. Candidate will have to submit a certificate of his/her fitness from a Government Medical Officer. Women candidate pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidate will be reexamined for the fitness from an Government Medical Officer.
- No TA/DA will be allowed to join the post.
- He/She will have to give a declaration to the effect that He/She has only living spouse, if married.
- He/She will have to take an oath of allegiance/faithfulness to be constitution of India or making solemn affirmation.
