Sir.

As we are aware that, children in schools are among the most vulnerable groups during any disaster. Therefore, schools need to prepare themselves for a major damaging event. Being prepared will improve the ability to respond to disaster. In such an event school administrators and teachers will have to be self-sufficient—relying on their own resources to protect and care for the student population and the immediate surrounding communities until external assistance is available. Though the country does not have a stringent code for school safety it is important that all schools develop emergency plans and conduct drills for various situations and hazards that are persistent in the region. Teachers, school staff primarily must know how to help their students during an event of disaster; therefore, they need more information and education on school safety and preparedness measures.

In order to address the school safety and preparedness issues in Government as well as private institutions, DMC, HIPA proposes to organize three days training programme on "School Safety in Disaster Management" from 04th to 06th May, 2017 for the School Principals, Lectures, Teachers as well as Incharge of Disaster Management at School level and Teachers from some local Public/Covent Schools of Shimla City. The objective of the programme is to sensitize/aware the participants on issues of disaster preparedness and safety measures and to motivate them through direct participants in activities that would foster towards a disaster resilient school community. Boarding and Lodging expenses of the participants would be borne by DMC, HIPA, whereas TA/DA would be borne by the nominating Institution/Department. The Institute will provide accommodation on twin share basis in HIPA hostels, however; participants may be directed not to bring their wards or family members along with them because the Institute will not be able to provide any accommodation to the wards or family members of the participants. Keeping in view the scarcity of parking within the HIPA Campus, the participants may also be advised not to bring their personal vehicle.
