
Regarding submission of Utilization Certificate.

Sir,

I am directed to refer to this department letter of even number dated 31st October, 2013 and subsequent reminders of even number dated 8th January ,12th May 2015 and 3<sup>rd</sup> September, 2015 on the subject cited above and to say that Utilization Certificates for the amount shown in the Annexure against you have not been received in this office despite repeated reminders. Recently audit of the accounts of this office was conducted and the auditor have raised para for non receipt of UCs from you. A considerable period has already lapsed and it has been observed that some of Deputy Commissioners have not even utilized funds which were released in the year 2011-12 and onwards. This not only attracts audit objection, but also delay the achievements of the objectives of capacity building and awareness generation for the disaster risk reduction.

You are again requested to send the UCs and ensure that the funds are properly utilized after completing all codal formalities. If any activity stand completed and funds are not required, then unspent funds may be refunded to this department so that the same are utilized on other activities. Since two professionals have been provided in each district, their services be utilized for completion of activities for which funds have been provided. This matter may be given top priority so that audit para could be settled.
