Minutes of the meeting with all the Deputy Directors of Higher Education, in Himachal Pradesh held on 03.09.2021 at 12:00 P. M. (through Video Conference) under the Chairmanship of Worthy Director of Higher Education, Himachal Pradesh, Shimla to discuss Golden Jubilee celebration of full Statehood.

Video Conference was held on 03.09.2021 under the Chairmanship of Worthy Director of Higher Education and detailed discussion was held for the actions to be taken for Golden Jubilee celebration of full Statehood.

First of all, worthy Director welcomed all the Deputy Directors of Higher Education. After that detailed discussions took place about the instructions already issued regarding Golden Jubilee Celebration of full Statehood w.e.f. 05.09.2021 to 14.11.2021.

Worthy Director of Higher Education explained in detail the purpose for celebration. Date-wise activities were discussed and detailed instructions were issued to all the Deputy Directors of Higher Education for making preparations in this regard.

In addition to the activities specified in the instructions the following decisions were also taken in the meeting:-

- 1 The activities are to be taken up as online/offline mode as per COVID situation and in accordance with COVID instructions and norms.
- 2 A Committee is to be constituted at District Level for the purpose of monitoring, reporting and documentation of activities to be taken up during the Celebrations.
- 3 All the Colleges/Schools should paint the logo of Swaran Jayanti at appropriate place.
- 4 All the Colleges/Schools should compile an exhibit the journey of education since 1971 or from the date on which the educational institutions came into existence through appropriate mode with active participation of students and teachers.
- 5 The progress in the field of Higher Education be compiled for each educational institution, Assembly Constituency and the District separately.
- 6 Documentary for the Journey of Education since 1971 be also prepared for the District/College and be sent to this Directorate by 15-10-2021.
- 7 The consolidated report alongwith photographs in the form of a booklet for the activities taken up to 31-10-2021 should reach the Directorate by 03-11-

2021 so that a booklet showcasing the journey of Higher Education since 1971 could be compiled in time before State level function on 14-11-2021.

8 The activities regarding Swarnim Himachal Rath Yatra shall also be organized as per directions of District Administration.

9 It was directed to prepare a list of five retired teachers for each district who have exceptional contribution in the field of Education and send it to the Directorate alongwith description by 25-09-2021.

10 All the Colleges/Schools should be in good condition in all respects and any demand relating thereto shall be sent immediately.

In addition to this the following instructions were issued:-

1 Latest status of Building/other works was directed to be sent within seven days and it was also directed to be readily available always.

2 The preparation of Disaster Management Plan is mandatory for every College/School and should be prepared immediately and report in this regard be sent to the Directorate within 15 days. It was also directed that DDHIEs Inspections shall also inspect the plan and preparedness of the school for Disasters.


3 Disaster audit be conducted for each college/School immediately and the report in this regard be sent within 15 days.

4 Report of the Disaster Management Committee of the college/school be sent regularly within three days of holding of the meeting of the committee.

5 It was directed that DDHIEs shall conduct immediate Inquiry in respect of sensitive issues without waiting for specific directions from this Directorate and send the report within 24 hours so as to take immediate necessary action in such matters.

6 The matter regarding uniformity in colour and painting of walls in all the Utkrishit Vidyalayas was discussed in detail and the proposals regarding colour combination for them was directed to be sent within a week.

The meeting ended with vote of thanks to and from the Chair.
