Subject: Regarding allotment of GPF number to subscribers from
retrospective date and subscription thereof.

Sir,

I am directed to refer to the subject cited above and to say that matter regarding allotment of GPF number to subscribers from retrospective date and subscription thereof was under consideration for some time taken up with the office of Accountant General, HP. The matter was taken up with AG, HP and has informed that there is no such provision in GPF rules regarding allotment of GPF account number to the subscribers from retrospective date and subscription thereof.

Presently IPH and PWD department's work charge employees converted into regular from retrospective date are subscribing to their GPF account after allotment of GPF account number and no deduction is being made for previous periods. Therefore, same pattern can be adopted in the cases of those employees other than IPH and PWD who are regularized from retrospective date (prior to 15/5/2003) and who are to be enrolled for GPF subscription. (Copy of the letter of Pr. AG is enclosed for perusal).

Accordingly, it has been decided to adopt ^{the} same pattern in cases of those employees other than PWD & IPH who are regularized from retrospective date (prior to 15/5/2003) and who are to be enrolled for GPF subscription.
