the certificates (i.e. DOB, Educational and other Higher qualification, Bonafide Himachali, Computer course, belonging to notified Backward Area or Panchayat , Land less family/family having land less than 1 Hectare to be certified by the concerned Revenue Authority, Non employment Certificate to the effect that none of the family member is in Government/Semi. Government, BPL family having family annual income (from all sources) below Rs 40,000/- or as prescribed by the Govt. from time to time, Widow/divorced/destitute/Single woman, Single Daughter/Orphan, Training of at least 6 months duration related to the post applied for from a recognized University/Institution, Experience upto a maximum of 5 years in Govt./Semi. Govt. organization relating to the post etc.) at Rajkiya Kanya Maha Vidlya (RKMV) Shimla, HP as per dates given to them.

It is further informed that typing test of all the eligible candidates will also conducted after verification of documents, therefore all are also directed to appear in the said test. However, as per Labour and Employment Department Order No. 11-3/75-EMP(Part) dated 07.09.1976, a disabled person can be exempted from passing the type test if the Medical Board/ Chief Medical Officer issued a certificate to the effect that the incumbent concerned is unable to do typewriting work due to disability. Hence, if you are unable to do the type test, same may be produced before the typing test committee for exemption in typing test
