Terms and conditions :-

PAY FIXATION

- (a) The pay will be fixed in the Cell 1 of Level 10 (i.e. Rs.38100/-) of pay matrix of HP Civil Service (Revised) Rules, 2022 and other allowances admissible from time to time.
- (b) Annual increment will be allowed after putting in one year continues services.
- (c) They will be on probation for two years which can be extended for another one year if he/she do not satisfactorily completes the probation period keeping in view the work and conduct of the official.

SENIORITY

- 1. Inter-se seniority amongst these regularized will be determined as per the date of initial engagement under PTA GIA Rules 2006.
- 2. If the date of engagement is same the senior in age will be considered senior.
- 3. If in some cases date of joining and date of birth are same then merit in BPEd/BPE/DPEd. qualification will be considered.
- 4. The seniority in the cadre will be drawn as per Govt. instructions issued from time to time.

Terms and Conditions :-

- (a) The post is temporary but likely to be continued.
- (b) Prior to granting the benefits of regularization every DPE shall have to submit following documents to their controlling/DDO:-
 - (i) A certificate to the effect that if he /she is married and having one leaving spouse.
 - (ii) Attested copies of all certificates of academic/professional qualification i.e. Matric onwards.
 - (iii) He/she shall have to take an oath of Allegiance/ faithfulness to the Constitution of India.





(iv) The candidate belonging to scheduled caste Scheduled tribe /Other Backward classes will furnish the requisite certificates on the prescribed proforma duly issued by the Magistrate 1st class of the area concerned.

(v) His/her retention in service is subject to his character and antecedents being found satisfactory which should be got verified by the concerned Principals of the GSSS.

(vi) He/she will have to given in witting whether he /she was never convicted by any court of Law and if any punishment which was imposed be stated. Concealing of facts will be liable for termination of services, if comes to the notice at any stage.

(vii) The candidate shall have to produce the bonafide Himachali certificate issued by the competent authorities.

(viii) An undertaking to this effect be taken from every DPEs that he /she has not concealed his/her qualification/bonafide resident of HP /category to which he/she belongs/martial status and any other relevant information. If at any stage it comes to the notice that the facts are concealed then, services shall be liable for termination without assigning any reason/notice.

(ix) An undertaking to this effect be taken from the regularized DPE that the financial benefits will be payable from the prospective date i.e. the date of acceptance of regularization.

(x) The regularized DPE shall be liable to be posted anywhere in the state.

(xi) The regularized DPEs should be medically fit for the post being considered for regularization. The regularization order of DPE concerned is subject to the production of medical fitness certificate from the CMO/Block Medical officer of the area concerned.
