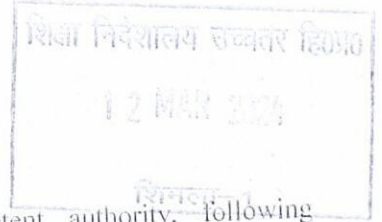
1. The Deputy Director of Hr. Education Shimla/Chamba/Kangra/Una/Bilaspur/Hamirpur (HP).
