Greetings from Navodaya Vidyalaya Samiti!

In accordance with the National Policy of Education 1986, Government of India started Jawahar Navodaya Vidyalayas (JNVs). Presently the JNVs are spread in 27 states and 8 Union Territories. These are co-educational residential schools fully financed and administered by Government of India through an autonomous organization, Navodaya Vidyalaya Samiti. Admission in JNVs is made through the Jawahar Navodaya Vidyalaya Selection Test (JNVST) to class VI.

The objective of the scheme is to provide good quality modern education including a strong component of culture, inculcation of values, awareness of the environment, adventure activities and physical education to the talented children predominantly from rural areas. Education in Jawahar Navodaya Vidyalayas is free including boarding & lodging, uniform and textbooks.

The Samiti has already conducted the Entrance Examination for admission of children to class VI in Summer Bound Jawahar Navodaya Vidyalayas on 11th January 2020. The Jawahar Navodaya Vidyalaya Selection Test for Winter Bound JNVs was scheduled on 11 April 2020, but could not be conducted due to Covid-19 Pandemic.

Now it has been decided to conduct the same on 7th November 2020. The successful completion of the test is the most crucial activity that the Vidyalayas have to undertake in the time of Covid-19 Pandemic this year. Social distancing and MHA guidelines will be followed for which separate protocol has been provided to all the centres.

I request you to extend your support by sending communication to all departments concerned to extend their support in smooth conduct of Jawahar Navodaya Vidyalaya Selection Test for Winter Bound JNVs of your state on 07<sup>th</sup> November 2020, by following MHA guidelines with the assistance of Principal of the concerned Jawahar Navodaya Vidyalaya in the District.

We look forward to your continued support in conducting the selection test successfully.
