## <u>ORDER</u>

Whereas, Sh.Kishori Lal, Lect(Hindi) is posted at GSSS Suni (Sml) and temporarily deputed at GSSS Sanjauli (Sml) w.e.f 13.03.20 on medical ground. Now for seeking his transferred on medical ground he filed CWP No. 3104/21 titled as Kishori Lal vs. State of HP. before Hon'ble High court which was listed on dated 31.5.21, when the Hon'ble Court has directed that :-

"Accordingly, the present petition is disposed of with a direction to respondents to consider the case of the petitioner for regular posting in GSSS Sanjauli, District Shimla in accordance with law within a period of four weeks from today. Pending applications, if any, stands disposed of.

And whereas, in compliance of Hon'ble High Court order dated 31.5.21, he was called for personal hearing on 28.6.21 and he was heard in person. During the course of hearing he has requested to adjusted him at GSSS Sanjauli (Sml) by transferring the present incumbent else where. However available vacancies were offered to him but he denied to opted any one of these vacancies.

And whereas, At present Smt. Hem Lata, is posted as Lect(Hindi)(SN) at GSSS Sanjauli w.e.f 26.07.20 and having short stay. As per transfer policy she can not be transferred from GSSS Sanjauli (Sml) just to adjusted the petitioner.

And whereas, after perusal of medical certificate issued by the MS DDU Hospital Shimla it is advice to the petitioner to avoid pro long standing travelling excessive exertion and worthily a feel and down hill etc. At present petitioner is posted at GSSS Sunni (Sml) which is situated in plane area and at that station there is no down hill travelling and Civil Hospital is also available with in 500 mtrs from the school.

Now therefore, after taking into account the above discussed detail facts and circumstances, his request for his transfer to GSSS Sanjauli(Sml) has been considered and rejected on the ground that the incumbent posted there having short stay and as per transfer policy she can not be transferred without completion of her normal stay at the station, however, keeping in view health status of the petitioner, he is allow to be on deputation at GSSS Sanjauli (Sml) for next three months upto 30.09.2021. This has been considered as per his request. During this period he will take on line classes of students studying at GSSS Suni (Sml) as per his duty requirement.

Accordingly representation stand disposed of.
