**These postings are subject to the following conditions:-**

1. The Promote JLA (s) will join their new place of posting (s) on or before 13.12.2019 positively failing which promotion orders shall deemed to be withdrawn automatically **for one year or next DPC whichever is earlier**. No specific orders with reference to withdrawal of promotion orders will be issued separately. **No extension will be given for joining in any case.**
2. The financial benefits will be admissible from the date of joining on the post of JLA. He/ She will be entitled TA/DA and joining time as admissible under the rule. He/She will have to



exercise their option within one month from the date of promotion for fixation of pay under rule FR22(i)a(i).

3. The promotee should report for duty to the concerned Principal with stipulated period. The Concerned Principal/ Headmaster will relieve the promoted Laboratory Attendant immediately.
4. The salary of the promoted JLA's for the next month will be drawn from the College of his/ her posting. If the promoted JLA is not willing to avail the promotion he/she has the right to forgo the promotion in public interest, the Principal will take the option of non-availing the promotion from the concerned LA. The copy of same will be pasted in his /her service book and the other copies as sent to this Directorate for taking further action.
5. In case the above promotee has already been transferred to other institutions, the concerned Principal/ Headmaster will ensure to send the promotion order to the institution where he/ she has been transferred and report thereof be sent to this Directorate immediately.
6. The Principal of the concerned institution shall take an undertaking if the concerned official to the effect that he/she is found unfit for promotion at later stage due to any reason i.e. any change in the Seniority /Disciplinary proceeding, etc, he/she/ will be revert to the original post of LA and the excess amount paid to him will be recovered in lump-sum and the same be recorded in his/her service book.
7. Before relieving the promotee JLA (s) the Principal/Headmaster of the concerned institution will ensure that he/she has passed his/her matriculation with science from recognised board of the school education. If any promotee found matriculate without science she/he may not be relieved and this Directorate be informed forthwith.
8. The Principal of the concerned institution shall take an undertaking if the concerned official to the effect that he/she is found unfit for the promotion at latest stage due to any reason i.e. any change of the seniority/disciplinary proceedings etc, he/she will be revert to the original post of LA and excess amount paid to him will be recovered in lump sum and the same be recorded in his/her service book.
