Dear Sir/Ma'am,

As you may be aware, the National Testing Agency (NTA) has been set up by the Ministry of Human Resource and Development, Government of India, as an Autonomous Body with the Cabinet approval, to function as an independent, autonomous, self-reliant and self-sustained organization for conducting prestigious entrance and fellowship examinations for admission to Higher Educational Institutions (HEIs).

NTA has been conducting the NEET (UG) entrance examination since May 2019, on the direction of the Hon'ble Supreme Court of India and as mandated by the Ministry of Health & Family Welfare, as per the rules/ regulations/guidelines framed by the Medical Council of India, for admission to MBBS/BDS Courses in Medical/Dental Colleges in India.

In the light of COVID-19 pandemic and under these extra-ordinary circumstances, the NEET(UG)-2020 is now rescheduled to be held on September 13, 2020 (Sunday) (in single shift) as a common and uniform Entrance Test throughout the country, for admission to the undergraduate medical courses in all medical institutions in the country, including those governed under any other law, as per Section 14 of the National Medical Commission (NMC) Act, 2019.

A list of Cities where NEET (UG)-2020 Examination is going to be conducted, is enclosed for your ready reference.

Since this examination is to be conducted in single shift on the same day as per the direction of the Hon'ble Supreme Court of India, you are requested to kindly ensure that the Schools in the Cities of your State are kept free from other examinations/ activities on 12th and 13th September 2020.

- a. As, it is one of the most prestigious examinations of India, kindly inform us as soon as possible, if it clashes with any other state exam, then candidates of your city/state will have to be sent to different cities and states for appearing in the examination.
- b. The teachers in the Exam Cities are also not detailed for any other duty on 12th and 13th September 2020, so as to enable them to be involved in the smooth conduct of NEET (UG)-2020 on 13.09.2020.
