As you are aware that the Govt. of India has given its approval to implement the National Education Policy, 2020 and Himachal Govt. has also decided to implement the same in our state.

For implementation of NEP-2020 by Ministry of Education Govt. of India, a consultation process with States/UTs was started in Nov.2021. For consultation purpose several workshops were organized at regional, zonal and national level. During the process of consultation three themes were identified- Access, Quality and Future Readiness. Concept Paper was also prepared on these three themes. Based on initiatives and learning from experiences of States/UTs, strategy and Roadmap for 2022-23 under each theme for 16 Action Areas was prepared in March, 2022.

You all are further requested to provide the exact status /information w.r.t. Key Performance Indicators of respective Action Areas.

In addition to the information about 16 Action Areas as mentioned above, you are also requested to provide information about major initiatives proposed to be taken by your University/College during 2022-23 under the following categories.

- 1. Student Centric Initiatives
- 2. Faculty Development
- 3. Institutional Development
- 4. Employability

Since the matter related to implementation of NEP-2020 is periodically reviewed and monitored at State Government level as well as Central Government level, therefore, all are requested to take this issue with utmost seriousness.
