The Information and Library Network (INFLIBNET) Centre is an Autonomous Inter-University Centre of the University Grants Commission to support the academic institutions in India through its various schemes and programmes. The Centre is involved in modernizing university and college libraries in India and is a major player in promoting scholarly communication among academicians, students and researchers in India through various initiatives like SOUL (Software for University/College Libraries), IndCat, e-ShodhSindhu, ShodhGanga, ShodhShuddhi, Vidya-Mitra, Vidwan, Plagiarism detection software. e-Content etc.


I am happy to inform you about the N-LIST, "National Library and Information Services Infrastructure for Scholarly Content" programme started in 2010 and funded by the MHRD through its project "National Mission on Education through ICT (NME-ICT)" which is now part of e-Shodh Sindhu: Consortium for Higher Education Electronic Resources, an Initiative of MHRD, Government of India since 2015 for providing access to scholarly content to Universities, Colleges, Centrally funded Technical Institutions (CFTS), IIMs, etc. The NLIST Programme currently provides access to more than 31.50 Lakh e-books and 6,500 e-journals to Govt./Govt. aided Colleges, recognised under the 12 (B) / 2(F) Section of UGC Act. While all Colleges recognised under the 12 (B) and 2 (F) section of UGC Act are eligible to access e-resources through N-LIST on payment of annual membership fee of Rs.5,900.00 (including GST), Non-Aided (2 (F) colleges) colleges (except Agriculture, Engineering, Management, Medical, Pharmacy, Dentistry and Nursing) may join the N-LIST Programme as its Associate Member on payment basis. The major advantage of NLIST is to get seamless access to the subscribed e-books and journals from anywhere, anytime, campus, home or even while travelling using user-Id having internet enabled PC/Laptop/Smartphone etc. It is pertinent to mention that during COVID-19, since the students and faculty members are away from their respective Colleges, thus the NLIST is a very effective and useful facility to provide the access of e-books and journals at home to the students and teachers. Further, it is bring to your knowledge that in Himachal Pradesh, only 25 Colleges are using the NLIST facility out of 82 Colleges and 57 Colleges are yet to become member of NLIST.

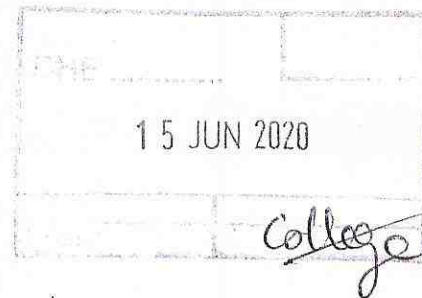


