NOTIFICATION

WHEREAS, the Government of Himachal Pradesh vide this Department Notification No. STE-F-(9)-1/2018 dated 20-09-2019 has imposed a complete ban on plastic cutlery such as spoons, bowls, katories, stirring sticks, forks, knives, straws made of plastic. This ban will be made effective after 3 months of date of publication of this notification in Rajpatra (e-Gazettee). The notification was published in Rajpatra on dated 25.10.2019 and now the ban shall come in force w.e.f. 26.01.2020.

AND WHEREAS, after issuance of this Notification, the Action Alliance for Recycling Beverage Cartons (AARC) represented to the Government of Himachal Pradesh to exempt integrated straws attached with tetra pack of beverages and keep it out of the purview of ban imposed vide notification dated 20.09.2019.

NOW, THEREFORE, keeping in view of above submissions, the Governor, Himachal Pradesh is pleased to exempt the use of integrated plastic straws attached with tetra pack of beverages temporarily, for a period of 6 months, subject to implementation of Action Plan submitted by M/s Tetra Pack India Pvt. Ltd., AARC under Extended Producer Responsibility. During the relaxation period, the manufacturers/producers shall come out with an alternative to plastic straw, which is bio-degradable. All other loose straws shall remain banned and other provisions as contained in the aforesaid notification dated 20-09-2019 shall remain unchanged. This notification shall come into the force with immediate effect from the date of
