"ORDER"

Whereas the petitioner Sh. Yash Pal DPE was transferred from GSSS Dhabas(SMI) to GSSS Irra(SML) vice Gopal Chand & vice versa on 09.04.2021, feeling aggrieved against these orders he filed CWP No. 2444/2021 titled as Sh. Yash Pal vs State of H.P and Sh. Gopal Chand DPE also filed CWP No. 2672/2021 titled as Sh. Gopal Chand vs State of H.P before the Hon'ble High Court. Since both the writ petitions was listed before Hon'ble High Court on dated 19.04.2021 & 28.04.2021 when the same was finally disposed with the directions to respondents as under:-

1. CWP No. 2444/2021 dated 19.04.2021

"This writ petition is disposed of by permitting the petitioner to file a representation by giving reasons and grounds for recalling the transfer order before the respondents-State/Competent authority within two weeks from today and the respondents-State/Competent authority are directed to examine the same and pass appropriate orders keeping in view Clause 5.4 of the transfer Policy within a week, thereafter, Till then, the impugned transfer order shall remain stayed, if the petitioner has not already joined at the transferred station.

2. CWP No. 2672/2021 dated 28.04.2021

"We find this submission of the learnes additional Advocate General genuine and close the present petition by permitting the present petitioner to file a representation before the concerned authority, at the earliest and not later than four days from today and the concerned authority is directed to decide both the representation simultaneously within week thereafter. Till decision of the representations, the petitioner, Gopal Chand, shall not be compelled to join at the previous place of posting. Pending miscellaneous application(s), if any, also stand disposed of.

And whereas upon passing of above directions, both the petitioners represented to the undersigned on 25.06.2021 & 28.06.2012 alongwith the copy of the directions dated 19.04.2021 passed by the Hon'ble High Court, HP.vide which the petitioner i.e. Sh. Yash Pal has requested that the earlier transfer orders dated 09.04.2021 may kindly be cancelled as he is on the verge of retirement as his retirement dated is 31.03.2022 or he may allow to continue at GSSS Dhabas(SML) till his retirement and another petitioner in CWP No 2672/2021 Sh.Gopal Chand DPE has also requested through his representation that he may be allowed to join at GSSS Dhawas(SML)after retirement of Sh. Yash Pal DPE i.e. on or after 01.04.2022.

Now therefore, after taking into account all the facts and circumstances of the case, the request of both the petitioners i.e. Yash Pal & Gopal Chand has been considered. Accordingly, Sh. Yash Pal DPE is allowed to continue at GSSS Dhabas(SML) till
