Subject: Policy to regulate the services of Part Time Workers.

Madam/ Sir.

In continuation of this Department's letter of even number dated 28-12-2021, it has now been decided by the Government that Part-Time Class-IV workers completing seven years of continuous service as on 31<sup>st</sup> March, 2022 and 30<sup>th</sup> September, 2022 in all Government Departments will be made Daily Wagers, subject to the observance of the following terms and conditions:-

- Part-Time Class-IV employees after completing 7(Seven) years of continuous service as on 31-03-2022 and 30-09-2022 will only be made Daily Wagers. Posts so vacated by such part-time employees shall stand abolished.
- The orders to this effect will be issued at the level of Heads of Departments after verifying the facts and record.
- For determination of date of birth of the candidate concerned, the provisions as laid down in Rule-172 of H.P.F.R., 2009 and instructions issued under Rule 7.1 of H.P. Financial Rules, 1971 Vol-I shall be observed.
- 4. The conversion to Daily Wager status will be with prospective effect i.e. after the date of issuance of these orders after completion of all codal formalities.

- The autonomous bodies, Boards, Corporations, Universities etc. are 5. not required to follow these orders mutatis-mutandis but should decide the same depending on their own financial position.
- 6. Such part-time workers, who have been engaged without being sponsored by the Employment Exchanges, may be given relaxation while conversion.
- 7 After converting the Part-Time Workers as Daily Wagers, the information should also be sent to the Finance Department for effective monitoring.

These instructions may be brought to the notice of all concerned for strict compliance and receipt of the same may also be acknowledged.
