## ORDER

Whereas, Sh. Pawan Kumar, Lecturer (School-New) (English) was transferred from GBSSS Lalpani (SML) to GSSS Ghanahatti (SML) vice Smt. Archana Chauhan, Lecturer (School-New) (English) and vice versa vide this office order dated 31.07.2023. Against these orders Sh. Pawan Kumar filed CWP No. 5206/2023 before the Hon'ble Court regarding his suitable adjustment in any school of Municipal Corporation of Shimla on his medical grounds as he is suffering from 80% permanent disability. The case was finally listed before the Hon'ble Court on 08.08.2023 when the case was disposed of with the following directions:-

"Taking into consideration the above submissions, more particularly, the disability being suffered by the petitioner, this writ petition is ordered to be treated as representation. Respondent No.2/competent authority is directed to decide the same, sympathetically, taking into consideration the disability suffered by the petitioner, within a period of one week from today in accordance with law and applicable policy. The decision so arrived at shall also be communicated to the petitioner. Till the decision of the representation, the petitioner shall not be compelled to join at the transferred station".

And whereas, upon passing of above directions, petitioner, Pawan Kumar, Lecturer (School-New) (English) submitted a representation and requested to adjust him either at GSSS Boileauganj, GSSS Fagli, GSSS Summer Hill or at GSSS Totu, Distt.

And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that at present the post of Lecturer (English) is not lying vacant at proposed stations.

Now therefore, after taking into account the above facts and circumstances of the case, representation of petitioner is considered sympathetically and Sh. Pawan Kumar, Lecturer (School-New) (English) who is under orders of transfer from the GBSSS Lalpani (SML) to GSSS Ghanahattti (SML) is adjusted in GSSS Tutikandi (SML) without TTA/JT vice Sh. Amar Chand, Lecturer (School-New) (English) who is being further transferred to GSSS Ghanahatti (SML) against vacant post within the radius of approximately 15 KMs with TTA/JT.

With these observations, representation stands disposed of.
