Rural Development, letter No. PCH-HA(4)16/76-IV-Loose-6706-10 dated 25.03.2023 and in view of instructions issued by Secretary (PR) to the Govt. of H.P. vide letter No. PCH-AA(4)16/76-Loose dated 03.04.2023 and as per latest **notification** of Ministry of Defence, Government of India, vide notification No. 19(101)/2010-D (Q&C) dated 27.04.2023 through which Yol Contonment Area has been ceased to be a cantonment, the following staff of AFCB, GHS, YOL Cantt. Dharamshala Distt. Kangra is hereby permanently absorbed in the Department of Higher Education, Himachal Pradesh against the sanctioned vacant post of Clerk in the school shown at column No. 06:-

The standard terms & conditions for permanent absorption are as under:-

- 1. The permanent absorption shall be strictly in the revised Pay Matrix corresponding to the prerevised pay scale of the post. In case of any official working in higher pay scale/grade pay in the parent cadre as a result of grant of benefit under ACPS, the higher pay scale/grade pay being drawn by such employees shall be protected on absorption as a measure personal and the difference need not be added in the pay band in accordance with H.P. Government Department of Finance (Regulation) letter No. Fin@F91)2/2012 dated 20<sup>th</sup> February, 2014.
- 2. The age of superannuation of the absorbed person from Yol Cantonment Board will be governed as applicable to the State Government employees.
- 3. The permanent absorbed person shall continue to draw their annual increments on normal date(s) of increment(s) which they as usual, used to draw in their own pay scales on the posts they held in the lending organization prior to their secondment/absorption in the borrowing office/organization.
- 4. The absorption will be on temporary basis and the absorbed employees shall remain on probation for a period of 02 years. In case their work and conduct is not found satisfactory during their probation period action will be taken as per rule.
- 5. The official being absorbed shall be placed at the bottom of their respect grade/cadre and seniority shall be determined on the basis of their absorption in the Department.

- The pensioners benefits to the official will be regulated as per the instructions of the State 6. Government issued vide FD's letter No. Fin (Pen) A (3) 1/97 dated 15.05.2003, as per the provision of H.P. Civil Services Contributory Pension Rules, 2006 notified by the Department of Finance (Pension) vide Notification No. Fin (Pen) A (3) 1/96 dated 17.08.2006 and as per Government Memorandum no. Fin(Pen)A(3)-1/2023 dated 04.05.2023.
- In the case of those employees who were appointed on or before 14.05.2003 on regular basis and 7. were governed by the CCS (Pension) Rules, 1972 in their parent organization, then the above condition No. 5 will not be applicable as they shall continue to be governed under aforesaid Rules for pensioner benefits.
- The employee will have to accept these terms and conditions before his/her joining to the post. 8.
- After absorption, if there is promotion to the next higher post, the incumbent will be promoted as 9. per prevalent R&P Rules.
