Implementation of ACPS under the Himachal Pradesh Civil Services (Revised Pay) Rules, 2022 and placement(s) in higher pay structures under the four/ three/ two tier pay structures - Cessation thereof.

Sir/Madam,

I am directed to invite your attention towards the subject cited above and to say that under the pre-revised pay structures, the Assured Career Progression Scheme(s) were applicable to various categories of the State Government employees circulated vide letters No. (i) Fin.(PR)B(7)-59/2010 dated 09.08.2012, (ii) Fin.(PR)B(7)-59/2010 dated 25.09.2012 (iii) Fin.(PR)B(7)-59/2010 27.09.2012, (iv) Fin.(PR)B(7)-59/2010-loose dated 26.08.2013, (v) Fin.(PR)B(7)-1/2013 dated 19.07.2013 (vi) Fin.(PR)B(7)-45/2010 dated 29.05.2014 and (vii) Fin.(PR)B(7)-45/2010 dated 14.11.2014. The Assured Career Progression Scheme(s) dated 15.12.1998/ 09.08.2012/ 07.07.2014 were applicable to all employees of the State Government, the ACPS dated 23.6.2000/ 09.08.2012/ 26.08.2013 were applicable to the officers of H.P. Administrative Services, H.P. Police Services, H.P. Forest Services, H.P. Health Services Class-I (Generalist), H.P. Health Services Class-I (Dental), Animal Husbandry Veterinary Class-I Services, Assistant Engineer, Assistant Architect, Assistant Town Planner, Additional Superintendent of Police/Deputy Superintendent of Police (Wireless), and ACPS dated: 4.8.2001/09.08.2012/27.09.2012 were applicable to Junior Engineers.

2. Similarly, under the pre-revised pay structures, three tier pay scales were allowed to the Assistant Automobile Engineer vide Notification Number:

Fin-(PR)B(7)-1/98 dated 1.9.1998, H.P. Agricultural Services (Class-I), Sub-Divisional Soil Conservation Officers/Divisional Engineer Soil Conservation vide Notification No. Fin.(PR)B(7)-1/98-III dated 18.5.2002, H.P. Horticulture Services (Class-I) vide Notification No. Fin.(PR)B(7)-1/98-IV dated 8.2.2005, Assistant Director of Factories vide Notification No. Fin(PR)B(7)-1/98 dated 19.7.2000 which were restored vide FD's instructions No. Fin(PR)B(7)-59/2010 dated: 25.09.2012 or instructions issued from time to time. Some categories of employees were allowed two tier pay scales whether proportionately or after completion of prescribed years of services in the pre-revised pay scales w.e.f. 01.01.1996, such as Clerks, Investigators, Staff Nurses, Technicians (Junior Technicians), Executive Engineers, Architect, Senior Hydrologist, District Town Planner, Town and Country Planner and Deputy Director in H&FW Department, which were restored while revising the pay structures w.e.f. 01.01.2006 or subsequent date(s) thereafter and also to various categories vide HPCS (Category/ Postwise Revised Pay) Rules, 2012 w.e.f. 01.10.2012 or subsequent date(s) thereafter.

- 3. The Himachal Pradesh Civil Services (Revised Pay) Rules, 2022 have been notified vide notification No. Fin-(PR)B(7)-1/2021 dated: 3<sup>rd</sup> January, 2022, and the above mentioned Rules take precedence over the pre-revised pay rules.
- 4. The above referred Assured Career Progression Schemes, four/ three/ two tier pay structures after completion of prescribed years of services, were applicable under the pre-revised pay structures, whereas no such scheme has been formulated/ notified under the revised pay structure. Therefore, as per notified HPCS (RP) Rules, 2022, benefits of existing ACPS/ 4-tier/ 3-tier/ two tier pay scales/ structures allowed to the categories referred to at Paras 1 & 2 above would not be admissible on or after the date of notification of HP Civil Services (RP) Rules, 2022, i.e. 3<sup>rd</sup> January, 2022.
- 4. These instructions shall also apply to all other categories of employees who were allowed three or two tier pay scales. It shall be the responsibility of the authorities concerned in their respective departments to ensure strict compliance of these instructions.

This may be brought to the notice of all concerned.

Decision of the Government relating to grant of Dearness Allowance to State Government Servants-Revised rates effective from 01.01.2016, 01.07.2016, 01.01.2017, 01.07.2017, 01.01.2018, 01.07.2018, 01.01.2019, 01.07.2019 and 01.07.2021 pursuant to revision of Pay Scales.

The undersigned is directed to say that consequent upon the revision of pay scales of the State Government employees, w.e.f. 01.01.2016 notified vide Himachal Pradesh Civil Services (Revised Pay) Rules, 2022 dated 3<sup>rd</sup> January, 2022, the Governor, Himachal Pradesh, is pleased to decide that the Dearness Allowance to the regular employees and officers of the Government of Himachal Pradesh, who have opted to be governed or are deemed to have elected to be governed or are brought to be governed by Himachal Pradesh Civil Services (Revised Pay) Rules, 2022, as the case may be, shall be admissible from the dates mentioned below at the following rates:-

Date from which payable	Rate of Dearness Allowance per mensem
From 01.01.2016	No Dearness Allowance
From 01.07.2016	2% of basic pay
From 01.01.2017	4% of basic pay
From 01.07.2017	5% of basic pay
From 01.01.2018	7% of basic pay
From 01.07.2018	9% of basic pay
From 01.01.2019	12% of basic pay
From 01.07.2019	17% of basic pay
From 01.07.2021	28% {3 installments of DA w.e.f 01.01.2020 (3%), 01.07.2020 (4%) & 01.01.2021 (4%) shall be admissible only notionally, without any arrears)}

The payment of Dearness Allowance under these orders shall be made from the dates indicated above, after adjusting the installments of Dearness Allowance already sanctioned and paid to State Government employees w.e.f. 01.01.2016 vide OMs number FIN(C)-B(7)-2/2006 dated 3<sup>rd</sup> October, 2016, 12<sup>th</sup> January, 2017, 1<sup>st</sup> April,2017, 11<sup>th</sup> September, 2017, 12<sup>th</sup> January, 2018, 27<sup>th</sup> October,2018, 18<sup>th</sup> February,2019, 21<sup>st</sup> August, 2019, 7<sup>th</sup> March, 2020 and 15<sup>th</sup> September,2021 and adjustment of 21% Interim Relief sanctioned vide OM No. FIN(PR)-B(7)-1/2016 dated 2<sup>nd</sup> August, 2016, 4<sup>th</sup> August, 2017, 9<sup>th</sup> February, 2018, and 20<sup>th</sup> August, 2018.

- 3. The term "Basic Pay" in the revised pay structure means the pay drawn in the prescribed level in the Pay Matrix, as defined in HP Civil Services (Revised) Pay Rules, 2022.
- 4. The HP Judicial Services Officers, employees of Subordinate Judiciary, the employees covered by the UGC Pay scale and the employees who are not governed by HP Civil Services (Revised Pay) Rules, 2022 will continue to draw Dearness Allowance on existing rates, till further orders and these orders will not be applicable to them.
- 5. The Dearness Allowance will continue to be distinct element of remuneration and will not be treated as pay within the ambit of FR-9(21).
- 6. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.
- 7. The Dearness Allowance shall be paid in cash with the salary of January, 2022 payable in February, 2022.
