Lackadaisical approach shall not be tolerated.

It seems that you are not bothered to obey the orders of the higher authorities, which amounts to misconduct/unbecoming behavior on the part of you.

So that further necessary action can be taken against the defaulters.

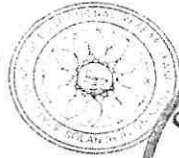
