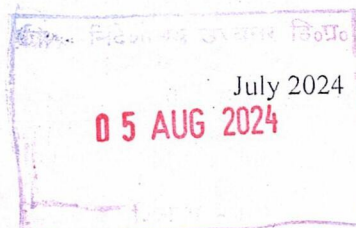

WHEREAS, the services of the staff of Pandit Anant Ram Sanatan Dharam College, Baroh, District Kangra, were taken over as Junior Lecturer Assistant purely on contract basis as per approval of the Govt. conveyed vide letter No. EDN-A-Ka(1)-15/2013 dated 21-10-2015 and they were offered appointment on 02-02-2016. Feeling aggrieved they have filed OA No. 2275/2017 in Hon'ble HPAT which was further registered as CWPOA No. 2050/2020 titled as Naveen Nischal Sood & Ors. vs. State of H.P. & Ors., with the contention that their services be regularized w.e.f. take over date of college on 07-02-2014. In compliance to HHC orders detailed reasoned orders were issued by the Secretary (Education) on 21-06-2024 wherein they have been allowed contract appointment w.e.f. 07-02-2014 with all consequential benefits.

AND WHEREAS, after allowing retrospective appointment w.e.f. 07-02-2014 and the regularization allowed in the year, 2019 is also to be re-considered.

NOW THEREFORE, the appointment order date and regularization date in r/o Junior Lecturer Assistants is revised as under:-
