On the subject cited above your goodself is informed that, so many inquiries are being received in the board office from various schools and candidates that they have passed their class 10th through SOS examination held in Sept. 2024 whose result was declared on 2-12-2024 by the board.

In view of the above, it is clarified that no such student will be eligible for appearing as a regular student in class +1 for March 2025 Examination as his / her attendance will not be 75% and above as per board examination regulation 4.4.1 & 4.4.2 and vide 4.3.1 concerned student will not fulfill the gap of 2 years between 10th & class 12th class accordingly.

Moreover, considering these cases for admission at this belated stage will lead to their rejection in various competitive examinations later on for want of mandatory gap and will jeopardize their future.
