**"ORDER"**

**Whereas** the petitioner Sh. Sunil Gautam, Lect./Lect.(SN) Biology is working at GSSS Cheuni, Distt. Mandi w.e.f. 18.12.2018 & as such his stay is almost complete. Now he is seeking his transfer to the station of his choice and filed CWP No 6226/2021 titled as Sunil Gautam Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 06.10.2021 when the same was finally disposed with the directions to respondents as under:-

**"The petitioner admittedly has completed his normal tenure in the tribal/ hard area by rendering service for more than two winters and three summers, therefore, he is entitled to be posted at a soft station, that too, at one of the stations of his choice. For that purpose, he has made a representation on 25.08.2021 (Annexure P-3).**

**Therefore, the writ petition is disposed of with a direction to the respondents to consider the case of the petitioner for his posting in any one of the stations mentioned in his representation and issue consequential orders within a period of four weeks from today. It is made clear that while relieving the petitioner, the respondents shall not insist upon for a substitute. Pending application(s), if any, shall also stand disposed of."**

**And whereas** upon passing of above directions, the representation dated 25.08.2021 has been perused and examined and it has been observed that he has requested for his transfer either at GSSS Gohar, (MND)/ GSSS Dehar, (MND)/ GSSS Phangwas, (MND)/ GSSS Majhwar, (MND)/ GSSS Barmana, (BLP), but all the incumbents posted at the stations of his choice having short stay and no post is lying vacant.

**And whereas,** as per transfer policy the incumbent posted at the stations of choice of the petitioner cannot be transferred in short stay. However he can be transferred any where against available vacancy if he opt for the same.

Now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and accepted to the extent that he may represent a fresh as and when the vacancy exists as per his choice of stations and same will be decided separately as per transfer policy. Accordingly his representation stand disposed of.
