

OFFICE ORDER

शिमला-1

Whereas, the petitioner were appointed in the department as JOA (IT)'s in the Education Department and they have joined in the year 2019 on contract/compassionate/daily wage basis and they were regularized as per Government directions from time to time i.e. after 03.01.2022. They have filed court cases, CWP No. 15877 titled as Himani Dhiman & Ors Vs State of HP & ors, CWP No. 15152 of 2025 titled as Meenu Devi & Ors Vs State of HP & ors., CWP No.15791 of 2025 titled as Chander Mani Vs State of HP & ors, CWP No.16312 of 2025 titled as Anil Kumar Vs State of HP & ors, CWP No.15713 of 2025 titled as Eena Kumari Vs State of HP & ors, Ex Pet. No. 2269 in CWP No.13077 of 2025 titled as Vishav Bharti Vs State of HP & ors and CWP No.17613 of 2025 titled as Ravi Chauhan Vs State of HP & ors before the Hon'ble High Court of HP and sought the benefit of judgment passed by the Hon'ble High Court of HP in CWP No. 1638 of 2024 titled as Mohit Sharma &Ors. Vs State of HP.

And whereas, Sh. Mohit Sharma has filed CWP No. 1638 of 2024 before the Hon'ble High Court of HP and same was been disposed of on dated 29.11.2024 with following order: -

*"Looking from any angle, it has to be held that petitioners are entitled to the benefit of higher stage of pay under Rule 7(A) of the Himachal Pradesh Civil Services (Revised Pay) First Amendment Rules, 2022, notified on 06.09.2022, on completion of two years of regular service.*

*This writ petition is accordingly allowed. Respondents are directed to release the higher stage of pay of Rs. 30,500/- to the petitioners w.e.f. their completing two years of regular service as Clerks. This is be done within four weeks from today. Pending miscellaneous application(s), if any, to also stand disposed of."*

And whereas, Ex. Pet. 79/2025 in CWP No. 1638 of 2024 was listed on 08.04.2025 and the Hon'ble Court observed as under: -

*"It was on 29.11.2024 that the judgment was passed, giving certain specific directions to the respondents. The judgment has still not been complied with by the respondents. Instructions placed on record on 05.03.2025 and 27.03.2025, from the Director, Higher Education, Himachal Pradesh, are only to the effect that the matter is under consideration at the Government level.*

*This stand cannot be accepted, as specific directions have been issued in the judgment. Let respondents file compliance affidavit within a week. It is made clear that this shall be the final opportunity for the purpose, failing which, appropriate orders shall be passed on the next date of hearing."*

And whereas, the Government has notified Revised Pay Scale Rule-2022 vide notification No. Fin-(PR)B(7)-1/2021 dated 03.01.2022 for Govt. employees as per clause 2.1 these rules, they shall apply to all the persons appointed on regular basis to the services and posts in connection with the affairs of the State of Himachal Pradesh and whose pay is debited to the Consolidated Fund of State of Himachal Pradesh. But as per clause 2.2 they shall not apply to the (g) persons employed on contract basis. And as per OM No. Fin(C)-B(7)-2/2021 dated 12.01.2022 Government has revised the emoluments of contract employees and fixed amount, equal to 60% (Sixty percent) of the first cell of the applicable level of the Pay Matrix of the corresponding cadre of employees, appointed/working on a regular basis.

Thereafter, as per Finance Department notification no. Fin-(PR)B(7)-1/2021-loose dated 06.09.2022 it was decided that the pay of employee of those categories/posts included in Schedule-II shall be fixed at higher pay stage in the concerned level of pay matrix after completion of two years regular service as given in Schedule-II". This rule shall apply to the employees who are appointed before 3<sup>rd</sup> January 2022.

**And whereas,** per Department of Finance notification No. FIN(PR)-B(1)-1/2021-LOOSE dated 23.06.2022 Government has allowed placement in higher pay structure on completion of two years regular service as was admissible under Re-revision 2012 to the government employees who were in position before the notification of HP Civil Services (Revised Pay) Rules, 2022 on 03.01.2022. It is also directed that the benefits of placement in higher pay structure shall also be admissible to the category of Junior Office Assistant (IT).

**And whereas,** in compliance of Hon'ble High Court orders in Ex. Pet. 79/2025 in CWP No. 1638 of 2024 Mohit Sharma Vs State of HP and direction conveyed by the Govt. vide letter No. EDUA-B015/157/2024-EDU-A/238106 dated 07.04.2025 & 08.04.2025 higher pay stage have already been allowed to Sh. Mohit Sharma and Smt. Ayushi Bahri, Clerk after completion of 02 years regular service vide order dated 08.04.2025.

**Now therefore,** in compliance of Hon'ble High Court orders in various Ex. Petitions and CWP's and as per approval conveyed by the Government vide letter No. EDUA-B015/157/2024-EDU-A/238106 dated 17.07.2025, higher pay stage in the concerned level of pay matrix after completion of 02 years regular service is hereby allowed to the petitioners as under: -
