Office Order

Whereas, the petitioners were appointed in the department as Clerks/JOA (IT) on contract basis and they were paid contract emoluments as applicable at that time as per instructions issued by Finance Department from time to time. They were regularized as per approval of the Government from time to time. Now, they have filed CWP No. 630 of 2026 titled as Narender Kumar & others Vs State of HP which was disposed of on dated 07.01.2026 as under: -

"Having regard to the afore-submissions, but without examining the merits of the matter, this writ petition is disposed of with a direction to the respondents/ competent authority to consider and decide the aforesaid representations of the petitioners of different dates (Annexure P-1, colly.) in accordance with law as well as taking into consideration the above judgment in the case of Ghanshyam Dass within a period of six weeks from today. The decision so arrived at shall also be communicated to the petitioners. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any".

And whereas, the case of Ghanshyam Dass in COPC No. 722/2024 in CWP No. 2056 of 2023 was taken up with the Government by the Director School Education, Himachal Pradesh and as per approval of the Government judgment passed by the Hon'ble High Court in CWP No. 2056 of 2023 has been implemented subject to final outcome of LPA.

And whereas, the petitioners have also filed the COPC No. 257 of 2026 before the Hon'ble High Court of Himachal Pradesh which is pending for adjudication. The matter has been taken up with the Government vide this Directorate letters of even numbers dated 07.03.2026, 30.03.2026, 22.04.2026 and 15.05.2026. Now, the Government has conveyed the approval vide letter no EDUA-B015/4/2023-EDU-A/122834 dated 15.05.2026 for implementation of the judgment dated 07.01.2026 passed by the Hon'ble High Court of HP in CWP No. 630 of 2026 subject to the final outcome of the LPA/Review Petition or any other legal remedy that may be filed or is pending in similar matter.

Now, therefore, in view of the facts and circumstances of the case and in compliance to the Hon'ble High Court order in CWP No. 630 of 2026 titled as Narender Kumar & others Vs State of HP and as per approval conveyed by the Government all the DDO concerned are hereby directed to fix the pay of the petitioners for the period they served on contract basis, at the minimum of revised pay band + grade pay along with such hike to which they are entitled to in terms of revised pay notification from 01.01.2016 to till their regularization as per Hon'ble High Court order subject to final outcome of LPA/ Review Petition or any other legal remedy that has been filed / pending in similar matter.

May inform the parties accordingly.


