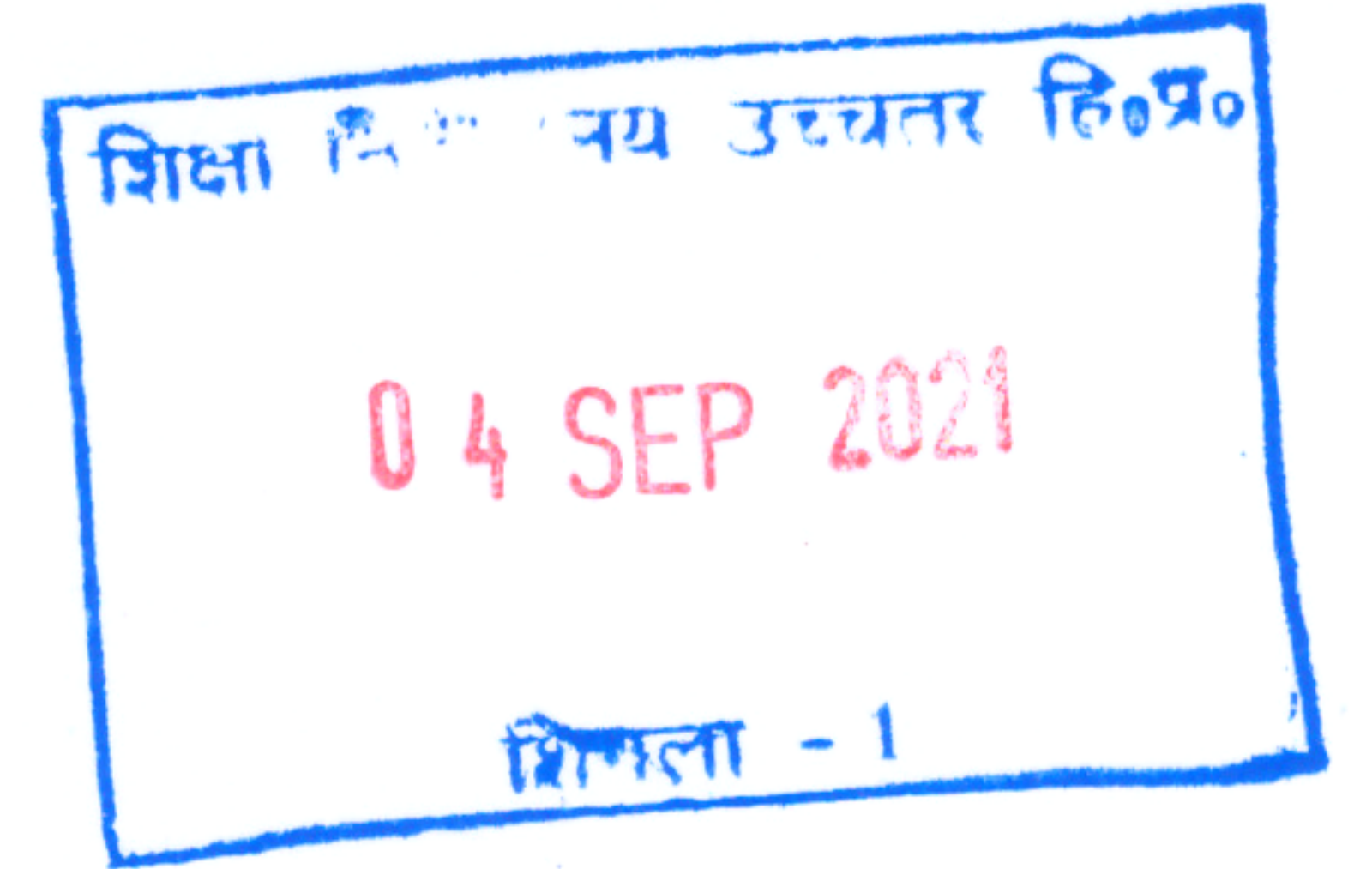




**OFFICE ORDER**
