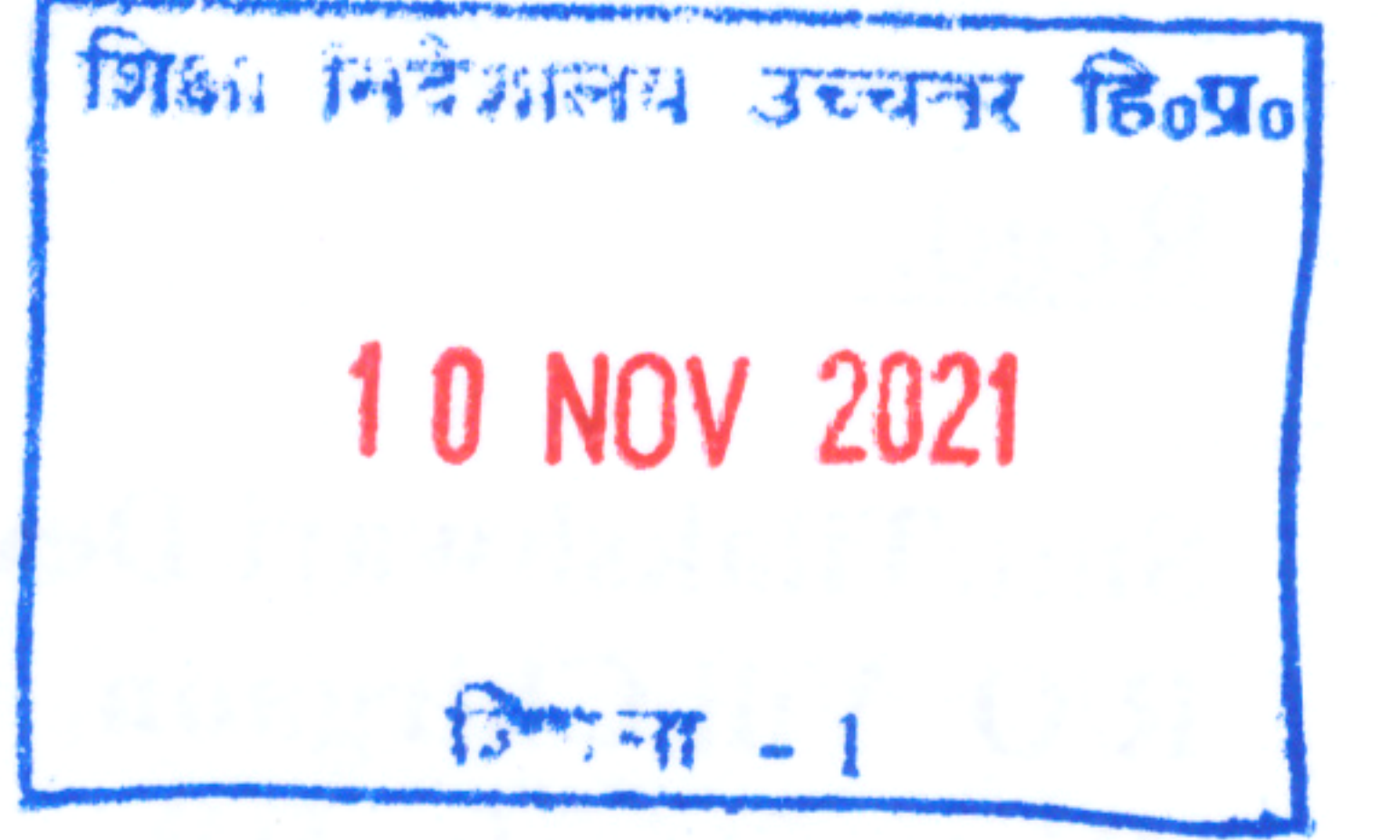

ORDER

Whereas, the applicant namely Smt.Tilkeshwari Devi Lect(Hindi) is working at GSSS Kanam (Knr) w.e.f 16.11.1998 & completed her normal stay. Now she is seeking her transfer to the station of her choice and filed CWP No. 4824/21 titled as Tilkeshwari Devi Vs State of H.P before the Hon'ble High court. This petition was listed before Hon'ble High court on dt 8.2.21 when it was finally disposed of with the direction to respondents as under :-

“ Confronted with this learned counsel for the petitioner states that a vacancy is likely to fall vacant at Government Senior Secondary School, Beolia District Shimla on 30th November, 2021.

If that be so we dispose of this writ petition by directing the respondents to consider the case of the petitioner for posting her in the said school in view of the fact that she has already served in tribal area for 23 years. However we make it clear that this order shall not be treated as a precedent in future as the same is being passed in the peculiar facts and circumstances of this case.”

And whereas, upon passing of above directions on dated 08.09.21 by the Hon'ble High Court her request for transfer from GSSS Kanam (Knr) to GSSS Beolia (Sml) against vacancy being caused due to retirement of present incumbent on 30.11.2021, has been considered and examined. It has been verified that the incumbent posted at GSSS Beolia is going to retire on 30.11.21 and post will be vacated there on dt. 01.12.2021.

Now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and she is here by transferred from GSS Kanam (Knr) to GSSS Beolia (Sml) against vacancy being caused due to retirement of present incumbent on dt 30.11.21 without TTA/JT. These order shall come into force on or after 1.12.21. Accordingly representation in r/o petitioner, Smt.Tilkeshwari Devi Lect(Hindi) stand disposed of.


